2.1. Board Designated Fund Reports (Information)

Mallory Pillard presented on HPLD's Summer Reading Adventure. Expressed gratitude to the Board for their funding, shared improvements to prize structure and incentive items selected.

Olivia Pratt presented on 100 Books Before Graduation. Expressed gratitude to the Foundation for funding a program that reaches a notoriously difficult-to-reach demographic. 600 teens currently enrolled in the program this year, which is an increase over last year's 350. Shared about teens submitting book reviews, which is not required but demonstrates their literacy skills and engagement with the program.

Kristin Jardin presented on Adaptive Fun. Shared some of the tools and items F&F funding has facilitated the purchase of. Has held two Adaptive Storytimes, for 11-15 people each time, and they have been well-received, with the hope that their tools and outlines can be borrowed and adapted across locations in the District

Director Starr is partial to the Summer Reading Adventure; his children have used it for many years and he likes how it sparks children’s interest in reading and participating in their local libraries.

Director Epperson’s current favorite resource is Hoopla and listening to audio books while she works, gardens, walks, etc.
